- 1. Full Paper must be written in good English free of various typing and grammatical errors to be fit for publication consideration.

- 2. The word limit of full paper is 8000 words.
- 3. All citations and references must be in sync and author shall make sure the paper doesn't infringe any copyright.
- 4. APA style of referencing for citation is to be followed to maintain the uniformity.
- 5. Full paper must be typed in MS Word in Times New Roman with font size 12 and 1.5 line spacing. All pages of the paper shall be numbered.
- 6. All submissions must include a title, an abstract, authors affiliation and designation details
